Eligibility Requirements- MRA Pageant held in 2026

By signing below, I confirm that I meet all of the eligibility requirements set forth below.

1. **Age:** I will be 21 years of age by November 1, 2026, and I will be no older than 26 years of age by December 31, 2026. Upon request, I will provide a copy of a government issued identification (such as a birth certificate, driver's license, passport, etc.) verifying my age.
2. **U.S. Citizen:** I am a citizen or lawful resident of the United States of America and authorized to work in the United States of America.
3. **Resident of State:** I am a resident of the State where I have competed in the State Pageant that I represent. I will provide a State issued driver's license to verify residency.
4. **Education:** I have obtained a high school diploma (or equivalent).
5. **Gender:** I was assigned female at birth, and I am female.
6. **Marital Status:** I am not currently married and have never been married.
7. **Parental Status:** I am not a parent of any child, and I am not pregnant.
8. **Good Character:** I am of good moral character. I have never committed or been involved in an act of moral turpitude.
9. **No Criminal Record:** I have not been convicted of any felony or misdemeanor crime (excluding minor traffic offenses). I agree to allow MRAI to run a background check.
10. **Health:** I am in good health, and I do not have any health concerns or physical limitations which would prevent me from fully participating in this contest or from serving as and fulfilling the duties of Miss Rodeo America if selected.
11. **Substance Abuse:** I do not use any illegal or controlled substances (other than prescription medications and then only in the manner prescribed). I do not abuse alcohol or drugs.
