**APPLICATION/CONTESTANT SIGNATURE:** I hereby attest to the fact that as a contestant in the Miss Rodeo Ogden Pageant that I am 18-26 years old, and I have never been married. If I should attain the Miss Rodeo Ogden title, I will remain unmarried during the official title reign. I promise to comply with all rules and regulations pertaining to Miss Rodeo Ogden. I will hold harmless the Ogden Pioneer Days Foundation, Ogden Pioneer Days, and pageant officials in the event of any injury occurring during my participation there. I will conduct myself in a manner befitting a contestant and/or the Miss Rodeo Ogden title and hereby agree to adhere to the pageant official's directions and requirements. If I achieve the title of Miss Rodeo Ogden, I agree to fulfill the appearances and obligations of the title as determined by pageant officials. I will also accept the responsibility to represent the Miss Rodeo Ogden title in competition at the Miss Rodeo Utah Pageant if I meet the age requirements for the Miss Rodeo Utah Pageant Should I win, I agree to represent the Miss Rodeo Ogden Queen title from May 10, 2025 until the selection of the new Miss Rodeo Ogden in 2026. I also understand that I am not free to schedule my own appearances and that all appearances as the Miss Rodeo Ogden Queen at any civic affairs, rodeos, clinics, or any other public appearances will be approved by the Pageant Coordinator or designee. I attest to the fact that I am a legal resident of the State of Utah, and no member of my immediate family is affiliated with the Miss Rodeo Ogden Pageant Committee. I understand and agree to provide and utilize my own horse for the pageant and I will execute two horsemanship patterns during the competition.

**Runner-Up Policy:** The Miss Rodeo Ogden Pageant will no longer select attendants. Instead, runner-up titles will be awarded. As a runner-up, you will not have any responsibility to attend Ogden Pioneer Days events or rodeo-related activities. However, in the event that Miss Rodeo Ogden is unable to fulfill her reign, the first runner-up will be asked to step in and assume all duties and responsibilities associated with the title. Without the obligation of serving as an attendant, runners-up are free to compete in other rodeo queen pageants throughout the year, expanding their chances to gain experience, earn titles, and ease the obligation and expense of traveling.
